Congress to tackle surprise billing

In the coming weeks Congress is expected to begin considering legislation that would work to address the issue of surprise billing. There is broad agreement that any legislation should protect patients from the failure of their health insurer to provide an adequate network of physicians. Patients who experience true "surprise bills" should be responsible only for the cost-sharing amounts that would have applied if their provider had been in-network. At the same time, steps must be taken to assure that plans are not given financial incentives to further restrict their networks or to offer physicians take-it-or-leave-it rates without negotiating in good faith.

In addition:

- When the minimum payment for out-of-network physicians should incorporate charge data from sources independent of payers or other stakeholders.
- When the minimum insurer payment for out-of-network care is insufficient, and independent dispute resolution (IDR) process should be used to determine a fair amount. The IDR should be structured with clear factors that the arbiter must consider when deciding, including the rate that physicians charge for that service in the area.
- At no point should negotiated, discounted in-network rates provided to contracted physicians or Medicare rates be used as a benchmark to determine fair payment to out-of-network physicians.
- To ensure that patients are completely protected, benefits should be assigned to the physician or other provider so that they may pursue payment directly with the insurer.

States that have adopted similar systems for health insurance markets they regulate have reported significant drops in the instances of surprise bill complaints. Any similar federal regulation should apply to ERISA plans that are beyond the reach of state regulation.

Congress should ensure that patients are reasonably able to access the benefits their health plans promised when they signed up for coverage. Insurers must also ensure that their provider directories are accurate and up-to-date so patients can make informed decisions about their care.

It is also imperative that any federal bill include strong and enforceable network adequacy requirements and that federal parity laws be enforced to ensure patients have access to innetwork physicians to prevent surprise bills before they happen.

Please <u>contact your members of Congress today</u> and ask them to support surprise billing legislation that protects the patient and holds insurers accountable for failing to provide adequate networks of physicians.

AMA, medical societies ask Congress to refine MACRA

The AMA along with 120 state medical and national specialty societies sent a <u>letter to</u> <u>congressional leaders</u> calling for refinements to the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA). MACRA remains an improvement over the sustainable growth rate formula it replaced, but the joint letter urges Congress to build on the lessons learned during the initial years of implementation to help physicians succeed and patients thrive.

Specifically, the AMA and medical societies urged Congress to replace the scheduled physician payment freeze from 2020 through 2025 under MACRA with positive payment updates to reflect increases in practice costs and preserve patient access. In addition, to provide physicians with a longer on-ramp to move to alternative payment models (APM), Congress should extend the APM incentive payments for an additional six years. Finally, the letter advocates that Congress work with the medical community to make technical improvements to MACRA, such as providing the Centers for Medicare & Medicaid Services (CMS) with greater flexibility to streamline reporting under the Merit-based Incentive Payment System (MIPS) and adjust APM participation thresholds.
